Project Location


- Project is centrally located within St. Lucie County - east of both I-95 and Florida's Turnpike
- Midway Road is an eastwest facility that is approx. 12 miles long
 - Begins at SR 70
 - Ends at Indian River Dr.
- Midway Road is owned and maintained by St. Lucie County





Location of this Widening Project

- The widening will begin east of Florida's Turnpike and will end at Selvitz Road – approx. 1 mile
 - 4 lanes from Selvitz to US 1
- The project is located in unincorporated St. Lucie County and marks the northern border of the City of Port St. Lucie
- Separate Turnpike Widening PD&E Study (FM# 423374-1-22-01) that includes Midway Interchange




Four Primary Reasons for this Widening Project

- 1. Provide additional capacity to meet existing and future traffic demands
- 2. Improve safety by alleviating congestion, thus reducing traffic delays and crashes
- 3. Safety and mobility for pedestrians, bicyclists and transit users will be greatly improved with the addition of sidewalks, a multi-use path and bus bays
- 4. Improve freight mobility and enhance emergency evacuation along the corridor



Schedule Milestones and Cost

- Design Completion: Late 2021
- Construction Start Date: FY 2026
- Estimated Length of Construction: 24 months
- Estimated Construction Cost: \$20.1 million



Construction Impacts

- Construction will be completed in phases to minimize interruptions to traffic.
- Construction activities will take place during daytime hours from Monday through Friday.
- One lane in each direction on Midway Road will always remain open, and local access will be maintained
